SBMH closes at one-month high

The SEMDEX gains 7.52 points closing at 2,438.08 (+0.3%). Market Value Commerce & Industry: H. MALLAC rises to Rs 19.00 (+1.3%), IBL Traded (MVT) for the day amounts to Rs82.7m on a volume of 6.6m shares declines to Rs 29.80 (-0.7%), MOROIL moves up to Rs16.00 (+1.6%), PIM traded.

Foreign Investors (FI) are net sellers with FI Sales (FIS) of Rs16.2m compared to FI Purchases (FIP) of Rs3.4m.

SBMH closes at one-month high of Rs6.10 (+3.4%), upon announcement of its half-yearly earnings. Value traded for the day amounts to Rs2.4m, accounting for 2.9% of total market turnover. At the current price level, its market cap and dividend yield stand at Rs I 8.5bn and 8.2%, respectively.

ICT: EMTEL eases to Rs21.00 (-1.2%)


